- All following subjects will run depending on the number of applicants and availability of staff and facilities (in practical subjects).
- Entry to some courses will be limited.
- Entry to <u>all</u> courses will be at the discretion of the appropriate Head of Learning Area.
- The final selection of standards for each subject (worth approximately 18-24 credits) will be made from the standards presented in this option booklet.
- The column labelled "CODES" contains:
  - R or W which identifies standards that can contribute to the Reading and Writing credits for the University Entrance Literacy requirements. Please follow the link below to see the full list of NCEA Level 2 standards that contribute towards Level 2 Literacy (reading / writing) <u>University Entrance Literacy List, January 2020</u>
- Course contributions listed for each subject include resources, activities and trips that are **highly recommended** as being conducive to optimal student learning. Please refer to each individual course descriptor for the compulsory items required for that course.
- NOTE: Can not choose both 3FAH and 3TEF (or Head of Subject discretion)
   Can only do 1 max of 3TEM, 3FDN and 3TEF
   Can not choose both 3DIT and 3DIP
   Can only do 2 max of 3PHO, 3DES and 3ART (and be wary of a 3<sup>rd</sup> high internal subject)
   Cannot choose 3MAT with either 3MAC, 3SAP or 3SPA

# VOCATIONAL PATHWAYS

Vocational Pathways is a Ministry of Education tool that has been developed to help students to plan their journey from secondary learning to the work force. Additional information about Vocational Pathways is available in the Level 1 - 3 information book.

The pathways will help students see how learning is relevant to a wide range of jobs and study options, in six broad sectors of industry:

On each option page there is a coloured ticked section indicating which standards relate to which industry sector.






### ENGLISH AS AN ADDITIONAL LANGUAGE


At Year 9 and 10 identified students may be removed from a Year 9 class or a Year 10 option line to attend ELS classes to support their language development.


# HEALTH & PHYSICAL EDUCATION FLOWCHART 2022



# LANGUAGES FLOWCHART 2022




# MATHEMATICS & STATISTICS FLOWCHART 2022






# SCIENCE FLOWCHART 2022




# SOCIAL SCIENCES FLOWCHART 2022

Classical Studies is a holistic study of ancient Greek civilisation. It covers philosophy, comedy, militarism, society, politics, drama, literature, history, art and architecture. Level 3 Classical Studies focuses on introducing the ancient world to students and on developing the skills necessary to study literary heavy subjects in Tertiary or beyond. The study of ancient history involves looking at all aspects of a society in order to piece together what life, beliefs and values would have been like of the people of that time, alongside the major historical events of the period. Level 3 Classical Studies focuses on the final years of the 'Golden Age' of Greece - 5th century BCE Athens, all the way through to the beginning of the Hellenistic Age in the 4th century BCE. The course begins with the philosophies of Socrates and his intellectual and social impact upon a defeated Athens. From here we look into a different perspective of the same issue, but now with the comedic plays of Aristophanes. Through the playwright, we witness what life

#### COURSE OUTLINE

By the end of NCEA Level 3, students can take part in general conversation with speakers of te Reo Māori, understand most of what is said, and contribute relevant comments. They can explain and discuss many of their own ideas and opinions and may use te Reo Māori creatively. They can read a variety of authentic te Reo Maori materials and write expressively for a range of purposes. Students use a range of strategies to help them learn te Reo Māori effectively, and they demonstrate a high level of fluency for a learner of te Reo Māori as a second language. The NCEA Level 2 course is the building block for NCEA Level 3 and helping students develop further independence in te Reo Māori.

The NCEA Level 3 course develops student skills in six different language modes—Listening, Reading, Viewing, Speaking, Writing and Presenting. In each of these modes students should be able to meet the following achievement objectives: communicate about certainty and uncertainty, possibility and probability; develop an argument or point of view with reasons; recount a series of events to inform, persuade or entertain; communicate the same information in different ways for different audiences; respond to selected texts in te Reo Maori that are about te Reo and tikanga Māori.

The usual mode of delivery for this course is through Te Kura (The New Zealand Correspondence School) with the support of a Māori language specialist within the school where this is possible.
